EDUCATIONAL COMPONENT

Everything starts with soil. Balancing life and death, the natural system at play in our soil is a wondrously efficient, self-sustaining ecosystem.

Division V, Exhibit *A Garden Metamorphosis* is the educational component of 2023 Florescence "Metamorphosis."

Statement of Intent: Years of spraying synthetic pesticides, weed killers, and fertilizers on our lawns, gardens, and farms have damaged the biology of our soil, which is essential for plants to live and thrive. GCH and ROGC will teach visitors how to create a healthy soil ecosystem through composting.

THE GARDEN CLUB OF AMERICA RULES

Please carefully read and follow GCA Rules, Museum Rules, General Information, Division Guidelines, and Timetable for Exhibitors. All rules, as stated in *The Garden Club of America Flower Show and Judging Guide*, July 2019 Revised Edition, shall apply.

- 1. All plant material must be correctly identified with botanical and common names on the entry card, if possible. Accepted references for nomenclature are: American Horticultural Society A–Z Encyclopedia of Garden Plants; plantsoftheworldonline. org; International Plant Names Index at ipni.org or international plantnames.com; Plant Systematics at plantsystematics.org; Royal Horticultural Society Plant Finder Database at apps.rhs.org.uk/rhsplantfinder; and Missouri Botanical Garden plant finder at missouribotanical garden.org.
- 2. The Garden Club of America expects all exhibitors to be aware of the need to promote conservation of endangered and threatened plants. Plants collected in the wild and listed by the Texas Natural Heritage Program may not be exhibited in any flower show sponsored by a GCA club. Cultivated plant material listed by Texas's Natural Heritage Program may be exhibited only if accompanied by a printed card stating that it has not been collected from the wild and giving information concerning its cultural requirements and methods of propagation. Natural Heritage Programs' list of endangered plant material will be available before and during the show from the Division Chairs and is available online at plants.usda.gov/threat.html. Additional plant information may be included if the plant was grown and collected out of state.

- **3.** Plant material showing evidence of insects or disease must be removed immediately from the exhibition area. This rule will be enforced at any time during the show, whenever the problem is identified.
- 4. Locally invasive plants, diseased plant material, artificial plant material, live animals (including fish), taxidermy, natural birds' nests, feathers of any kind, and protected sea life, including coral, are not permitted. The use of natural sea shells is strongly discouraged. www.plants.usda.gov/java/noxiousDriver

THE MUSEUM OF FINE ARTS, HOUSTON RULES

- 1. The protection and preservation of the art is the top priority of the Museum of Fine Arts, Houston (MFAH). The following rules regarding all Florescence exhibits will be strictly enforced at all times. Failure to comply with these rules may result in disqualification and removal of an exhibit.
- 2. Safe distance from art must be maintained.
- **3.** Pedestals, tables, and risers may not be moved or repositioned as they are all carefully placed by MFAH personnel. In addition, classes with dimension limits will be closely monitored for compliance.
- 4. If a floral design includes any found or foraged materials (e.g., branches, dried wood, or other natural materials) these components must be pre-treated for insects by the floral supplier or by the designer. Safer Soap or Garden Safe non-toxic sprays are recommended.
- 5. The amount of water in floral supply buckets must not exceed three inches in depth, and any additional water needed must be coordinated by MFAH personnel. The only exception to this rule is the official Florescence Preservation Committee. Bringing water into the galleries from restrooms or water fountains is strictly prohibited. Floral supply buckets should always be placed on top of plastic on the floor. Floral supply buckets may not be placed on work tables, chairs, etc. Please note that drinking water, beverages, and food of any kind are not allowed in the galleries.



THE MUSEUM OF FINE ARTS, HOUSTON RULES (continued)

- 6. Misting of exhibits in the galleries is prohibited. Exhibitors may not mist any material, including any material for Floral Design (whether a completed arrangement or backup material in buckets or boxes) or any material for Horticulture (whether container-grown, cut specimens, or completed Horticulture Designs). The only exception to this rule is the official Florescence Preservation Committee. The Committee will monitor the condition of exhibits overnight and maintain all in pristine condition.
- 7. Actively using paint or glue and applied design elements such as beads or glitter within the MFAH is prohibited. Paint, shellac, mastic, adhesive, glue, or any other such material, whether aerosol spray, non-aerosol spray, bottle, can, or jar is not permitted inside the MFAH. Glue guns, paint pens, and glitter pens are not permitted inside the MFAH. If you are using applied items, all such items must be adhered and all paint and glue fully dried and set before arrival at the MFAH.
- **8.** Flash photography is prohibited in the MFAH. Only the official Florescence photographers may use flash photography.

Please help the MFAH ensure the safety of its collection for the generations to come.

GENERAL INFORMATION

- 1. Entries are open to all GCA club members, including provisional, and professionals in their disciplines, except as noted in the schedule.
- 2. Registration is required for all classes, with the exception of those in the Horticulture Division II.A that are weather dependent (cut specimens, etc.). Registration is online only, at flohouston.org. Classes will be filled in the order in which registration forms are received according to the online date and time. Confirmation of registration will be sent to entrants by email. Direct any questions to Registration Chairs.
- **3.** Entering a show constitutes permission to use images of the submitted contest in all GCA channels of communication.



- **4.** While The Garden Club of America, The Garden Club of Houston, River Oaks Garden Club, and the Museum of Fine Arts, Houston, will exercise due caution in safeguarding exhibits, responsibility for damage, loss or personal injury cannot be assumed.
- **5.** Any clarification or change in the rules, as originally stated in the schedule, shall be communicated promptly in writing by the Division Chairs to all exhibitors in the class and, at the show, to the Judges, and to the Passing Committees.
- **6.** An entry card must accompany each entry. Entry cards will be available for download at flohouston.org, at the show, and upon request from the entry or Division Chairs, in advance of the show. Information required on the entry card must be completed in black waterproof medium. Entry cards downloaded from flohouston.org should be printed on white cardstock.
- 7. The Passing Committee must pass each entry before an exhibitor may leave the show area. The Passing Committee reserves the right to refuse any entry that does not conform to the rules of the schedule. The exhibitor has the option of correcting the entry, if time permits. If not corrected, the entry cannot be judged, but may remain in place, marked "For Exhibit Only" with a brief, constructively worded statement explaining why it was not judged. The Judges may not disqualify any entry passed by the Passing Committee, unless evidence of insect infestation or disease is identified.
- **8.** Once an entry is passed, the exhibitor(s) must leave the show floor immediately. The only exception will be Flower Show Committee members who have entered and been passed according to the timetable. A passed entry may not be touched again by an exhibitor until after judging and then only to carry out necessary maintenance.
- 9. Only participating Judges and Clerks, Clerks Chair, and members of the Ribbon Brigade will be allowed on the show floor during judging. Flower Show Chairs and Division Chairs should remain nearby but off the show floor until needed.
- 10. All containers and accessories must be inconspicuously labeled with the exhibitor's name.



GENERAL INFORMATION (continued)

- 11. A novice is an individual-exhibitor who has not won a first-place ribbon or a GCA Special Award in the division entered at a GCA Major Flower Show or a Sanctioned Non-GCA Major Flower Show. An exhibitor winning first place in a GCA Flower Show is still considered a novice in a GCA Major Flower Show or a Sanctioned Non-GCA Major Flower Show or in another division of any flower show. In addition, an exhibitor who has won a first-place ribbon or Special Award in a GCA Major Flower Show or Sanctioned Non-GCA Major Flower Show is no longer a novice in any level of GCA Flower Shows in the division won. Only individual novice exhibitors are eligible to receive the Sandra Baylor Novice Floral Design Award or the GCA Novice Award. A novice exhibitor will be identified on the entry card, following the initial judging.
- **12.** A statement of intent, if required or permitted, must be submitted by the time of passing. The statement must be no more than 25 words, typed or printed.
- **13.** Photography exhibits must be removed ONLY by MFAH personnel and will be available for pick up on Friday April 28, 2023, after 12:00 p.m. for in-town exhibitors from Nancy Keely, 5 Lana Lane, Houston, TX 77027.
- **14.** For a \$25 flat fee, an out-of-town exhibitor's Botanical Arts and Needle Works entry may be returned by a shipping service. Please go to flohouston.org for information. The method for the return of out-of-town Floral Design and Photography exhibits are detailed in the Division Guidelines or at flohouston.org.
- **15.** Entrance to the MFAH will be limited during staging and entry times. Name tags will be required for entrance and timelines will be strictly enforced.
- **16.** At no time may exhibitors touch any exhibit other than their own.

Guidelines

Please carefully read and follow the GCA Rules, Museum Rules, General Information, and Timetable for Exhibitors.

- 1. An exhibitor is permitted only one entry per class but may enter more than one class. The exhibitor(s) under whose name(s) the entry has been registered must create and complete the design. All participants must be listed. Only listed exhibitors and show personnel may be on the show floor at the time of entry.
- 2. No more than two exhibitors may execute a floral design unless otherwise stated in the schedule.
- **3.** If forced to withdraw, an exhibitor must notify the Registration Chairs and class consultant and find a substitute unless there is a waiting list for the class.
- 4. Mechanics should not be visible unless they are an integral part of the design.
- 5. All designs must be executed at the show; complex components requiring extensive time for construction may be prefabricated and assembled during the allowed installation time at the show.
- 6. All entries must include fresh and/or dried plant material. Fresh plant material must be in water or conditioned in such a way as to remain in pristine form while on exhibition. Rooted plant material is allowed provided no soil is attached. An entry not maintained in show condition may have its award removed.
- 7. Anything not prohibited in the MFAH rules, GCA Rules, Floral Design Division Guidelines, or individual class descriptions is permitted.
- **8.** Cut fruits and vegetables are not permitted. Food of any kind is not permitted. Neither fur nor hair, shells, or bones, are permitted.

Division I: Floral Design Evolution Guidelines (continued)

- **9.** Judging will be based on the principles of design: balance, contrast, dominance, proportion, rhythm, and scale; and the elements of design: light, space, line, form, color, texture, pattern, and size. Creativity is important, as are distinction, conformance to, and interpretation of the class and schedule. For the scale of points for Floral Design, please refer to the *GCA Flower Show and Judging Guide* Chapter V, Section IX or follow the link at flohouston.org.
- 10. Accessories are permitted, unless otherwise stated in the class description.
- **11.** Pedestals may not be moved. Tops of pedestals may not be enlarged or draped. Floral designs have no height restrictions unless specified.
- **12.** Registration is open Tuesday, September 20, 2022, through Monday, January 30, 2023, online at flohouston.org. For questions regarding registration, please contact the Registration Chairs.
- 13. Color reproductions of works of art, where applicable, will be online at flohouston.org. It is possible the colors will not match the actual colors of the piece of art perfectly and the Judges will be made aware of this.
- **14.** Museum collections are subject to change. If this occurs, the Floral Design Committee will notify exhibitors as soon as possible.
- **15.** A plant list with the botanical and common names along with a mandatory statement of intent, of no more than 25 words, should be entered using the entry form online at flohouston.org by Monday, April 10, 2023. Changes may be made at the show.
- **16.** Challenge Class 4 is open only to individual out-of-town GCA members of the Judging Program, at any level, and the required fee of \$95 must be paid at the time of registration at flohouston.org.
- 17. All entries must be removed on Friday, April 28, 2023, between 8:00—10:00 a.m. An out-of-town exhibitor's entry may be returned by a shipping service for an additional fee. Please go to flohouston.org for additional information.

Guidelines

Please carefully read and follow the GCA Rules, Museum Rules, General Information, Division Guidelines, and Timetable for Exhibitors.

Ownership Requirements

1. Entries must have been owned and grown by the exhibitor for a minimum of six months (October 26, 2022) unless otherwise stated in this schedule.

Exceptions are as follows:

Classes 1–4 and 80–87: three-month ownership, January 26, 2023

Classes 92-93: nine-month ownership, July 26, 2022

Classes 94-105 and Class 118: one-year ownership, April 26, 2022

2. An exhibitor is permitted up to three entries per class, provided each is a different species or different cultivar.

Plant/Specimen Requirements

- **3.** The maximum length of an entered cut specimen is 26" measured from the lip of the container to the end of the vine, branch, or leaf, unless otherwise specified in the class description. Exceptions apply to Classes 88–91.
- **4.** All cut specimens must be in show condition at the time of judging. Wilted specimens are subject to removal by the Horticulture Committee. See GCA Rule #3 regarding condition of plant material.
- **5.** More than one plant per container is permitted, provided it is the same genus and same species, unless otherwise stated in this schedule.
- **6.** Leaf shine or other commercial foliage enhancers are not permitted.

Container Requirements

- **7.** Committee will provide plates for Classes 79-80, but exhibitors may use their clear glass container.
- **8.** Containers are measured at the diameter or the diagonal of the widest point on the inside of the rim at the soil line. Containers may not exceed 10". Exception to container size applies to Classes 97, 104, and 112, which may not exceed 8" and Class 118, which may not exceed 14".
- 9. Container-grown plants should be exhibited in clean terracotta clay pots. Disguised double-potting and top dressing are permitted. Plastic pots, if used, must be double potted inside a terracotta clay pot. Top dressing must not float when watered. Coffee grounds are not permitted as a top dressing. Moss is permissible as a top dressing.
- **10.** To designate a preferred exhibiting side, exhibitors should mark the center back of the container with a white chalk mark "X".
- 11. Mats, stands and saucers are not allowed. If an entry is staked (such as a forced bulb or an orchid), the support must be as unobtrusive as possible.

Entry Cards

- 12. Entry cards are available for download from flohouston.org and from GCAmerica.org, from the Division Chairs or the Horticulture Committee in advance of the show, and at the show.
- **13.** An entry card must include the name of the exhibitor, division, class, botanical and common names, and length of ownership. Entry card must be printed in pencil or generated by computer in black ink.
- **14.** Entry cards printed from flohouston.org or GCAmerica.org should be printed on white cardstock. A key card (diagram or plant list) is required when multiple species or cultivars are exhibited in the same container. Key card must be in pencil on a 4" x 6" white unlined card or completed online and printed on cardstock in black ink and be legible. See GCA website for required information. A 4" x 6" photograph with identifying numbers may be used to supplement the key card.
- **15.** A GCA horticulture propagation card, if applicable to the entry, should be downloaded from GCAmerica.org and printed on white cardstock. Information must be legible.





Division II.A: Horticulture *Grow* Guidelines (continued)

16. Entries eligible for the Elizabeth Platt Corning Medal and/or the Louise Agee Wrinkle Horticulture Propagation Award must have been grown by and in the possession of the exhibitor for at least six months (October 26, 2022) and will be identified by a checkmark on the entry card. Entries eligible for the Novice Award also will be identified by a checkmark on the entry card. A novice is an individual exhibitor who has not won a first place ribbon or a GCA Special Award in Horticulture of a GCA Major Flower Show or Sanctioned Non-GCA Major Flower Show.

Entry Process

- 17. Only GCA club members, Museum personnel, and plant experts approved by the Horticulture Division Chairs may be in the passing area of the Show. Only GCA club members may participate in the entry process. Exhibitors bear the ultimate responsibility for their own entry.
- **18.** Plant Inspection is the first station in the physical entry process. Plant Inspection closes at 9:00 a.m. on Wednesday, April 26, and no entries will be accepted at Plant Inspection after 9:00 a.m. Any entry presented at Plant Inspection after 9:00 a.m. may not be entered into the Show.
- **19.** A dot with the entry number will be affixed to the container, to the entry card, and to the key card (if applicable) in order to ensure accurate staging and judging.
- **20.** Once an entry has been passed, it may not be touched by anyone other than the Placement Committee, the Horticulture Chairs, the Show Chairs, or the Clerks.
- **21.** Classes may be subdivided, and entries moved and/or reclassified at the discretion of the Horticulture Committee, the Show Chairs, and/or the Judges.

Judging

22. Entries will be judged on horticultural merit and conformance to schedule.

Removal

23. All exhibits must remain as placed and judged until 9:00 p.m. on Thursday, April 27, 2023. Container plants will be held until Friday, April 28, 2023, at 8:00 a.m., and cut specimens will be discarded if not retrieved by 8:20 a.m. Exhibitors are responsible for their own entries.

Division II.B: Horticulture Design From the Ground Up Guidelines

Please carefully read and follow the GCA Rules, Museum Rules, General Information, Division Guidelines, and Timetable for Exhibitors.

- 1. There is no length of ownership requirement.
- 2. Live, rooted plant material must dominate the design. No cut flowers are allowed in Classes 2 or 3.
- 3. Accessories are permitted in Class 2.
- **4.** Classes 1 and 3 will be displayed on a 15.5" x 15.5" square pedestal that is 34" high.
- **5.** Class 2 will be displayed on one half of a 6' long table with a white tablecloth.
- **6.** All exhibits will be viewed from all sides.
- 7. Exhibitors are permitted only one entry per class but may enter more than one class. Each exhibit must be the work of the exhibitor(s) under whose name(s) it has been registered. All participants must be listed on the online entry form. Only listed exhibitors and show personnel may be on the show floor at the time of entry.
- **8.** Once an entry is passed, the exhibitor must immediately leave the show floor.
- 9. No more than two exhibitors may execute an entry.

- **10.** Registration is open Tuesday, September 20, 2022, through January 30, 2023, online at flohouston.org. For questions regarding registration, please contact the Registration Chairs.
- 11. If forced to withdraw, an exhibitor must notify the Registration Chairs and the Division Chairs and then find a substitute, unless there is a waiting list for the class.
- **12.** Containers are provided in Classes 1, 2, and 3. No structural alteration of provided containers is permitted. Embellishment permitted to the provided containers in Class 2 only.
- **13.** A plant list with the botanical and common names along with a mandatory statement of intent, of no more than 25 words, should be entered using the entry form online at flohouston.org by Monday, April 10, 2023. Changes may be made at the show.
- 14. A key card (diagram identifying the plant material) is required for all classes on a 4" x 6" unlined white card, and must accompany the entry. The information must be written or printed in black waterproof medium. A 4" x 6" photograph with identifying marks may be used in lieu of a drawn diagram. Multiple cards may be used to complete all information; note the division, class, and entry number on each card and clip cards together.
- **15.** Entries must go through Plant/Bug Inspection prior to entering the museum. Plant/Bug Inspection is located in the Horticulture Entry area in the MFAH Parking Garage and Visitor Center, 1144 Binz Street.
- **16.** After clearing Plant/Bug Inspection, entries should be brought to Gallery 207 to be PASSED IN PLACE.
 - See General Information #6 and #7 for information on passing.
- **17.** Entries will be judged according to the scale of points for Horticulture as stated in the Florescence Metamorphosis Schedule under Horticulture Design Class.
- **18.** Horticulture Design Class 1 is not eligible for a GCA Special Award other than Best in Show.
- **19.** All exhibits must be removed on Friday, April 28, 2023, between 8:00–10:00 a.m.

Guidelines

Please carefully read and follow the GCA Rules, Museum Rules, General Information, and Timetable for Exhibitors.

- 1. This is a juried show. The first eighteen online registrations for each class (by date and timestamp of registration) will be accepted for evaluation by the jury. The jury will choose six finalists in each class.
- 2. An exhibitor may submit only one entry in a class but may enter two classes.

Registration

- **3.** Advance online registration, including image, is open Monday, November 28, 2022, at 10:00 a.m. CST through Monday, January 30, 2023, at midnight CST at flohouston.org.
- 4. Photographs should be submitted in JPEG format, 1MB-5MB in the RGB colorspace. Each photograph must include the entrant's last name, first initial, zone and class number (e.g. Smith.J.IX.Class5.jpg). Questions regarding this process should be directed to Nancy Keely at nancydaviskeely@mac.com.
- Exhibitors will be notified by email that their registration and image have been received.
- **6.** The finalists and non-finalists will be notified of the juried results by Friday, February 17, 2023.

Photographic Requirements

- 7. A photograph previously entered in any GCA Flower Show, GCA Major Flower Show, Sanctioned Non-GCA Major Flower Show, or a GCA Focus online contest may not be entered again, even with slight alterations. The same photograph may only be entered in one show at a time.
- **8.** Only the Photography Committee may reclassify an entry, but only with the permission of the exhibitor.
- 9. Each photograph must be the work of the exhibitor, under whose name it is registered. In manipulated photographs, any added imagery must be the work of the exhibitor. Non-representational commercial overlays and textures are allowed. Mounting and printing may be done professionally.
- 10. Editing at any stage must be the work of the exhibitor under whose name it is registered. This includes enhancement for color or clarity, removal of a part of the image, combining images, or distorting the original subject. All post production must be done before the photograph is submitted for jurying.
- 11. Photography entries are limited to subjects consistent with The Garden Club of America interests such as horticulture, floral design, gardens/landscapes, conservation and the environment, historic preservation, civic improvement, and the natural world. Plant material is not required in every class, but is strongly encouraged in photographs.
- 12. Mixed media is to be a separate class and is not able to be juried.

Finalists' Entry Process

- 13. All photographs must be two-dimensional and printed on paper unless otherwise specified. Photographs must be flush-mounted on black foam core and may not be over-matted. This may be professionally done. Overall dimension of entry must be a minimum of 48" and not exceed 72" in total perimeter measurement. Glass and framing are not permitted.
- 14. The printed photograph must match, including cropping, the digital image sent with the original registration. Once juried, you may not further edit or manipulate the digital image in any way, as registered with us. The photo will not be passed if the Photography Committee determines:
 - a. The print is significantly different from the digital submission.
 - b. The print is mounted incorrectly.
 - c. The mounted print does not appear to be in Show condition.



- 15. Photography entry forms may be found online at flohouston.org. Two copies are to be submitted with each finished photograph and must include the exhibitor's name, garden club, zone, email address, physical address, phone number, and class entered. One entry form is to be attached to the back of the photograph. The top of the photograph must be indicated. A duplicate loose copy of the entry form must accompany the entry (allowing the statement of intent and other information to be accessible after the entry is installed).
- **16.** A title or statement of intent MUST be included on the entry form and the entry card itself, not to exceed 25 words.
- 17. Finalists' printed photographs must be received no later than Monday, March 20, 2023. Send photographs to Nancy Keely, 5 Lana Lane, Houston, TX 77027.

 Receipt of your photograph will be acknowledged. For information, contact Nancy Keely at 713-201-6281 or email nancydaviskeely@mac.com.
- 18. All photographs will be passed by the Photography Committee to verify that class specifications have been met, with a final passing date of Monday, March 20, 2023. If a photograph is not passed, the exhibitor will be notified and allowed, if time permits, to send a replacement photograph.
- 19. Photographs will be hung on a gallery wall.
- **20.** The Division Chairs will provide an entry card to be staged with each photograph. Identification of plant material on the entry card is not required, but encouraged whenever possible.
- **21.** Only appropriate images of a child or children should be submitted to, passed, and exhibited in the Photography Division and published in *Focus*. Featuring identifiable people (other than in street scenes) in photographs is discouraged, as GCA requires a release.
- 22. Although discouraged, if a photograph is to be returned, the exhibitor must provide a self-addressed return label and envelope. Any award received will be noted on the back of the mount before it is returned. GCA recommends using two 15" x 19" bubble wrap envelopes. Boxes shipped will NOT be saved for the return, only envelopes. Wrap your mounted image between two suitable pieces of foam core or non-bendable cardboard, which will be reused for return. Florescence is not responsible for any missing packing materials or damage to the photograph. Place wrapped image and folded self-addressed return envelope inside the mailing envelope.

Postage

23. Please include a \$15 check (payable to Florescence) to cover return postage and handling. Please do not enclose stamps, UPS labels, or postage-meter strips. Transformations Guidelines



Please carefully read and follow the GCA Rules, Museum Rules, General Information, and the Timetable for Exhibitors.

- 1. Registration is open and online only at flohouston.org from Tuesday, September 20, 2022, through Monday, January 30, 2023.
- 2. Exhibitors are permitted only one exhibit in each class, but may enter more than one class. No more than two exhibitors may execute a Botanical Arts entry unless otherwise stated in the schedule. All participants must be listed on the entry card. Botanical Arts Chairs are permitted to enter, provided they do not receive the completed entries in the mail.
- **3.** If forced to withdraw, the exhibitor must notify the Division Chairs and the class consultant and find a substitute unless there is a waiting list for the class.
- 4. All plant material used must be dried—this includes flowers, foliage, seeds, pods, nuts (in or out of shells), vegetables, twigs, vines, reeds, etc. Only plant material, mechanics, and their surface treatments (e.g., paints, nail polishes, varnishes, waxes) are permitted. Exhibitors may not use glitter, artificial, or endangered and locally invasive plant materials.
- **5.** Figural forms must be assembled or judiciously carved by the exhibitor. Any plant material may be cut, incised, or shaped to enhance the artistic effect.
- **6.** Non-plant material (e.g., cardboard, metal, twine, string, cording) may be used only for construction and must not show.
- 7. Exhibitors may not use processed products or manufactured materials (e.g., couscous, pasta, tapioca, balsa wood, milled wood, toothpicks, loose glitter, or thick coatings of resins or epoxy).

- **8.** Each entry must be the work of the exhibitor under whose name it is registered. The exhibitor must execute all handiwork.
- **9.** Botanical Couture entries must be created from all dried plant material. While the plant material may be treated, no mechanics or structural base may be visible.
- **10.** Mounts will be supplied to the entrant upon registration.
- 11. A sample/key card on an unlined 4" x 6" index card must accompany each exhibit. Affix a sample of each untreated plant material used in the design and label with botanical and common names.
- 12. A statement of intent of 25 words or less is required and must be submitted with the entry form. A statement of intent is a brief written paragraph offering explanation of the exhibit's message that the exhibitor intends to convey.
- 13. All mailed entries must include a photograph and must be received no sooner than Monday, March 23, 2023, and no later than Monday, April 3, 2023. Send entries to Virginia Mary Brown, 5530 Tupper Lake Drive, Houston, TX 77056. Inquiries may be directed to Virginia Mary Brown by email at vmtbrown@gmail.com or phone at 713-562-2507
- **14.** Hand-delivered entries are encouraged and may be turned in at the MFAH on Tuesday, April 25, 2023, between 1:00 p.m.–5:00 p.m. The entrant must stay until the entry has been passed.
- **15.** If an exhibit has won first place or a GCA Special Award in a GCA Flower Show, GCA Major Flower Show, or Sanctioned Non-GCA Major Flower Show, it may not be entered in competition again. An exhibit, which has been previously entered and did not place first, may be entered again if the piece is significantly altered.
- **16.** The Botanical Arts Chairs will review all mailed entries to verify that class specifications have been met. If time permits, an entry may be returned for correction.
- 17. The Botanical Arts Chairs will be responsible for installation of the exhibits. Each exhibit will be handled with the utmost care. Indicate in writing, and include with the exhibit, any special instructions for handling and display.



18. All entries must be removed on Friday, April 28, 2023, between 8:00 a.m.—10:00 a.m. For an additional charge, an out-of-town exhibitor's entry may be returned by a shipping service. Please go to flohouston.org for more information.

"The Gorham Fleurs you will pick will last forever" was an enthusiastic advertising slogan Gorham chose to describe their Fleurs des Siècles gift line. The flower arrangements, produced from the early 1970s to mid-1980s contain an amazing variety of flowers, leaves, nuts, and berries. Each jeweled metal flower or leaf is handcrafted, and hand enameled over gold plate. These exquisitely arranged bouquets are tucked into sterling and gold-plated cachepots, authentic reproductions of antique porcelain vases, various baskets or blooming within Murano glass domes.

A Garden Metamorphosis

Guidelines

Please carefully read and follow the GCA Rules, Museum Rules, General Information, and Timetable for Exhibitors.

- **1.** The purpose of the Education Division classes is to provide opportunities for multidisciplinary entries to educate the members and the public.
- 2. All designs must be executed at the show; complex components requiring extensive time for construction may be prefabricated and assembled during the allowed installation time at the show.
- **3.** Anything not prohibited in the GCA Rules, Education Division Guidelines, or individual class descriptions is permitted.
- **4.** The Committee will water the exhibits if instructed to do so in writing. Notify the Division Chairs at time of entry with written instructions for watering.
- **5.** The scales of points by which the exhibit and educational component will be judged are:

Division V is the Education Component of this GCA Major Flower Show. Its purpose is to increase appreciation, awareness, or knowledge of a subject.

Registration and Entry

- **2.** An exhibitor is permitted only one entry per class, but may enter more than one class with permission from the Division Chairs. Each exhibit must be the work of the exhibitor under whose name it has been entered.
- **3.** If forced to withdraw, an exhibitor must find a substitute unless there is a waiting list for the class. The Division Chairs must be notified immediately of any changes. Canvases must be returned if an entry is withdrawn.
- **4.** A registration fee of \$125, must be paid at the time of registration and includes canvas and finishing, but does not include threads that must be selected and purchased by the exhibitor. Contact the Division Chairs for payment information.
- **5.** Exhibitors may ship or deliver entry/entries to Lisa Bailey, 6003 Park Circle Drive, Houston, TX 77057. Entries must be received no later than Thursday, November 17, 2022.

Material Requirements

- 6. Canvases will be distributed upon receipt of registration and fee.
- 7. There are no thread requirements. Beading and embellishment are allowed.
- 8. All canvases will be finished in the same style by the Division Chairs.
- 9. Consultants may be used for the design of the stitches.

Passing and Placement

- **10.** All entries will be passed by the Division Chairs on Monday, November 21, 2022, to verify class specifications have been met.
- **11.** The Division Chairs will install all of the exhibits. Each exhibit will be handled with the utmost care, but the Chairs assume no responsibility for damage, loss, or personal injury before, during, or after the show.

Canvas and finishing provided by the Division Chairs. Displayed hanging and viewed from the front.



GCA Major Flower Show Awards described below have been applied for and will be presented if merited.

Division 1: Floral Design

Fenwick Medal may be awarded to members of GCA clubs in competitive floral design classes at a GCA Major Flower Show. It is offered in recognition of creative work of outstanding beauty using predominantly fresh plant material. The awarding of the Fenwick Medal lies in the clear interpretation by the Judges of the intent of the medal. A standard of creativity and quality in a highly competitive show rather than Best in Show is required. The design must have placed first, second, or third. An entry in a challenge class is not eligible to receive this award.

The Margaret Clover Symonds Medal may be awarded to members of GCA clubs in a competitive floral design class at a GCA Major Flower Show. The design must be an innovative, modern design, creatively combining man-made material(s) with fresh and/or dried plant material (as the schedule permits). Either individual or joint entries are eligible. The entry must have placed first, second, or third. An entry in a challenge class is not eligible to receive this award.

The Sandra Baylor Novice Award may be given at a GCA Major Flower Show to an exhibitor who is a member of a GCA club and who has never won first place or a GCA Special Award in the Floral Design Division of a GCA Major Flower Show or Sanctioned Non-GCA Major Flower Show. It shall be awarded to an individual novice exhibitor for a unique and skillful response to the schedule. Novice entries placing first, second, or third in any competitive class, including challenge classes, are eligible for this award.

The Carol Coffey Swift Medal of Excellence may be awarded to members of GCA clubs. It is offered in recognition of an arrangement of great distinction in a competitive class at a GCA Major Flower Show. Either individual or joint entries are eligible. The entry must have placed first, second, or third. An entry in a challenge class is not eligible to receive this award.

Division 11: Horticulture

The Certificate of Excellence in Horticulture may be awarded at a GCA Major Flower Show to GCH clubs or club members, nonmembers, or other organizations for an exhibit of great distinction in a competitive horticulture class. The entry must have place first, second, or third.

The Elizabeth Platt Corning Medal may be awarded only to members of GCA clubs only in a competitive horticulture class in a GCA Major Flower Show. The medal is to be awarded to an entry presented with distinction and originality notable for its cultural difficulty. It must have achieved an exceptional standard of horticultural excellence. Extra consideration will be given to an entry propagated by the exhibitor; full propagation details must be listed on a card accompanying the entry. The exhibitor must have owned and grown the exhibit for at least six months. The medal may be awarded for a single plant, collection of plants, container garden, or cut specimen(s). Individual, joint, or club entries are eligible. The entry must have placed first, second, or third. The medal may not be awarded more than once to the same exhibit.

The Louise Agee Wrinkle Horticulture Propagation Award may be awarded at a GCA Major Flower Show to a GCA member for skill in plant propagation. The exhibit must have been propagated and grown by its exhibitor for at least six months and should be distinguished by its prime condition, cultural perfection, attractive presentation, and flawless grooming. It is for rooted plants propagated by seed, cuttings, or other traditional methods. It can be a single specimen, source plant and its offspring, or a collection. Propagation methods must be detailed on an accompanying card. The medal may not be awarded more than once to the same exhibit.

Division III: Photography

The Certificate of Excellence in Photography may be awarded at a GCA Major Flower Show to GCA clubs, an individual club member, individual nonmember, or other organizations for an exhibit of great distinction in a competitive photography class. The entry must have placed first, second, or third.

The Photography Creativity Award may be awarded at a GCA Major Flower Show to an exhibitor who is a member of a GCA club for creative and technical excellence in response to the theme of the schedule. The entry must have placed first, second, or third.

Division IV: Botanical Arts

The Botanical Arts Creativity Award may be awarded at a GCA Major Flower Show to a member of a GCA club for excellent craftsmanship and creative response to the theme of the schedule. The entry must have placed first, second, or third.

The Certificate of Excellence in Botanical Arts may be awarded at a GCA Major Flower Show to GCA club members or non members for an exhibit of great distinction in a botanical arts class. The entry must have placed first, second, or third.

Divisions 11,111, & IV: Horticulture, Photography, and Botanical Arts

The GCA Novice Award may be given at a GCA Major Flower Show in the Horticulture, Photography, and Botanical Arts divisions to an exhibitor who is a member of a GCA club and who has never won first place or a GCA Special Award in the division entered in a GCA Major Flower Show or Sanctioned Non-GCA Major Flower Show. It shall be awarded to an individual novice exhibitor for an outstanding exhibit. Novice entries placing first, second, or third are eligible for this award.

Novice: A novice is an individual exhibitor who has not won a first place ribbon or a GCA Special Award in Horticulture of a GCA Major Flower Show or Sanctioned Non-GCA Major Flower Show.

Division V: Education

Large Exhibit Awards

The Ann Lyon Crammond Award may be presented at a GCA Major Flower Show to an outstanding educational exhibit which best educates the public about gardens. Any educational exhibit that increases the appreciation of any aspect of plants, gardens, or landscape design may be considered for the award. The award may be given to GCA club members, member clubs, nonmembers, or other organizations.

The Certificate of Excellence in Conservation may be awarded at the GCA Major Flower Show to GCA clubs or club members, nonmembers, or other organizations for an exhibit of exceptional merit which educates the public on conservation issues and promotes respect for natural resources and responsibility for environmental stewardship.

Educational Component

The Education Award may be awarded to an entry by a GCA club member, a class, a division or an entire show for an exhibit of exceptional merit which educates the public in keeping with the purpose statement of the GCA. An entry must have placed first, second or third.

FLORESCENCE AWARDS

Overall

Best in Show selected from among the first-place winners, may be awarded in: Each division (except Division V).

Judges' Commendation may be given to:

An entry, class, section, special exhibit, or other aspect of the show that is of exceptional merit.

Award of Appreciation may be given to:

An exhibitor or group for participation. The award may also be given to non-judged classes.

Novice Award may be awarded to:

A first time winner in each division (except Division V).






